Dear Friends:

Over the past year, Catholic Charities continued to strengthen its ties with the Baltimore community in new and dynamic ways. In our efforts to serve West Baltimore, we opened the St. Edward's Workforce Development Center, a program that provides training for West Baltimore residents interested in careers as automotive and general service technicians. It is co-located in the school building with one of our Head Start sites at St. Edward's in the Mosher neighborhood and at the National Center on Institutions and Alternatives (NCIA) Training Center in Milford Mill. It has already impacted lives, as more than 30 people have been trained, certified, employed or in the process of being employed as automobile service technicians.

Catholic Charities launched Safe Streets Baltimore in February to curb violence on the streets of the Sandtown-Winchester community. In partnership with the Baltimore City Health Department, the No Boundaries Coalition, St. Peter Claver Parish and others, Safe Streets Baltimore is a visible presence in this neighborhood that has been disproportionately affected by gun violence. Safe Streets is an evidenced-based, public health approach to violence that saves lives and dramatically reduces gun violence in communities where it has operated.


We marked three anniversaries this past year. On June 1, we commemorated the 35<sup>th</sup> anniversary of Our Daily Bread with an interfaith prayer service. For nearly 13,000 consecutive days, Our Daily Bread has been open to feed the hungry of Baltimore. That is more than 7 million meals served to our neighbors who were hungry by tens of thousands of volunteers. It is also the 20<sup>th</sup> anniversary of Christopher Place Employment Academy. Over the past two decades, nearly 1,000 men have moved from homeless and dependent to employed, living in the community and independent.

This year is also the 35<sup>th</sup> anniversary of our Senior Housing Communities. In 1981, Basilica Place opened on Franklin Street in Baltimore, and since its opening of 200 residences, 23 other Senior Communities have been opened. Catholic Charities now has 1,800 residences that are home to nearly 2,000 older Marylanders.

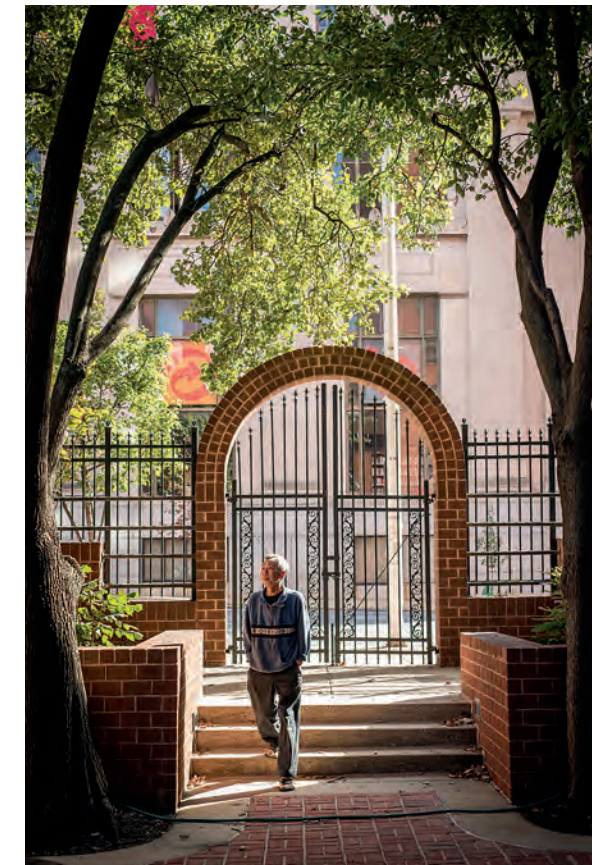

## OUR MILESTONES

### CHRISTOPHER PLACE (AT TOP)

Over the past 20 years, Christopher Place Employment Academy has helped nearly 1,000 men change their lives and create more fulfilling journeys for themselves.

### OUR DAILY BREAD

Since first opening its doors in 1981, Our Daily Bread (ODB) has served more than 7 million meals and currently serves nearly 700 meals each day, seven days a week, and has never missed a day serving meals in spite of blizzards, hurricanes or other events. Throughout 2016, ODB commemorated its 35th anniversary with an interfaith prayer service, Hungry for Change poverty forum, volunteer appreciation events and regional receptions.

### BASILICA PLACE

The beautiful garden and outdoor patio are just some of the many reasons Basilica Place has been a wonderful place for seniors to call home for 35 years.

WHEN A FAMILY IS IN CRISIS, children are often our canaries in the coal mine—the first to show signs of stress. They act out at home as they try to process events they don't understand and may face disciplinary consequences at school, beginning a cycle that can derail their long-term academic success. Villa Maria School-Based Behavioral Health Services places licensed therapists in more than 100 schools throughout Maryland, where, as members of the school community working with teachers and school counselors, they offer individual, family and group therapy, parent support groups, case coordination services and referral to other services to help children succeed in school and life.

After her divorce, Gina Tackett not only had to adjust to life as a single parent, she also felt overwhelmed by her younger son, Eutaw's anger and destructive outbursts. Getting counseling to help her family navigate the challenges of a major life transition was difficult for a parent juggling school drop-offs and after-school activities for two young boys. Then, she learned that her son's school offered counseling through the Villa Maria program.

"As a single mom, I get support, and I can manage it on our schedule," she says, "and I really do see growth and improvement." For the past three years, the program has been "a grounding place" for Gina, helped Eutaw connect with his emotions and make better choices and has opened up better lines of communication between mother and son.

Gina explains, "Our counselor, Amanda Weaver, is a wonderful partner for me. I keep her up to date on what's going on, and she checks in with him at school, helps him assess his choices and gives him tools to deal with his emotions. I've always given him every opportunity to build his amazing talents, from theater camp to TWIGS at School for the Arts for drumming to athletic activities, like skateboarding, swimming and diving. Life is difficult, and therapy can be very helpful. I'm grateful I can give this to Eutaw now so he can find the right path at the very start of his life."



# GETTING OFF TO A GREAT START

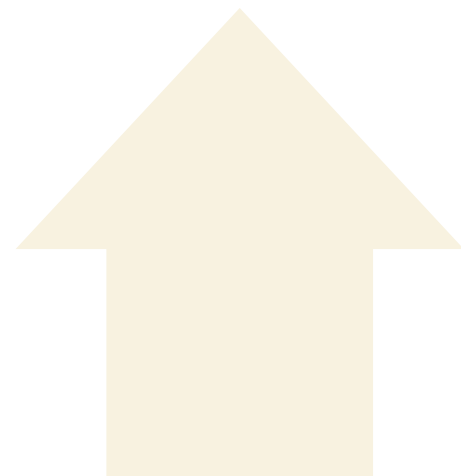
**FOR MORE THAN 50 YEARS**, Esperanza Center has helped non-English-speaking immigrants find their way to productive lives in Maryland. Starting with services for Cuban immigrants in the 1960s, Esperanza Center today welcomes more than 5,000 clients a year from around the world with services ranging from English as a Second Language (ESL) education and health care to low-cost immigration legal services. It has expanded, recently opening a second location to accommodate its rising client base. It has served the surge of recent unaccompanied minors from Central America with legal and family reunification services and works in partnership with other organizations to support victims of trafficking and domestic abuse, like Essadiya.

# A PLACE CALLED HOPE

**W**hen Essadiya Souidat was growing up in rural Morocco, she had two dreams—to become a nurse and to raise a family. Arriving in the U.S. on a fiancée visa, she believed one dream was about to come true. Instead, she landed in a nightmare.

“My husband did not want a wife,” she recounts. “He wanted a servant. I was happy to work hard, but nothing I did was ever right. He spent time with other women, locked me in a room without food, beat me and forced me to have sex. He tried to have me deported by filing for divorce without telling me. I did not want to go back because my mother was sick, and I was afraid to tell her what had happened.”

Emotionally exhausted and knowing almost no English, Essadiya came to Esperanza Center through a shelter for Muslim women. “At that moment,” she says, “my will was depleted, but the people here were kind and gave me hope. Now, I feel transformed. I can see my life changing day by day.” Attorney Victoria Lenes helped her file for residency through a process for spouses of domestic violence. Today, Essadiya has a green card, a job and a home of her own. She takes English classes and is again nurturing her earliest dream—a plan to study nursing. She recently visited her mother in Morocco, happy to have a different story to tell.



# REACHING A CROSSROADS

AS BALTIMORE reached a critical crossroads in the wake of the 2015 Freddie Gray unrest, Catholic Charities partnered with the National Center on Institutions and Alternatives (NCIA) and One Baltimore for Jobs (IB4J) to create the St. Edward's Workforce Development Center. The center offers hands-on job training for West Baltimore residents in a 12-week program that leads to Automotive Service Excellence (ASE) certification in Refrigerant Recovery and Recycling. Since it began, 34 trainees have completed the program, and 23 have found employment with the program's job placement assistance. New classes begin every three months.

For Harrelle Felipa, a single father raising six of his 12 children, this program gave him a fresh start after two years of unemployment. He learned about it at the Homeless Persons Representation Project when he was seeking help for a delinquent water bill. "I wasn't interested in auto mechanics, but," he says, "it was fast-paced, and it captivated me." Certified mechanic Tony Jones motivates his adult students by building camaraderie in the small garage where they work, giving them real projects from the first moment they arrive so they can build a sense of accomplishment, introducing required reading in small increments as their commitment and interest builds and getting to know and respect each individual.

Sticking with the program was tough, but Harrelle says, "I'm a role model for my children by always learning, holding a job, being productive." He was a member of the first graduating class and quickly landed a job. He is thankful that his entry-level position gives him a chance to keep learning and hopes eventually to open his own business. He often comes back to the shop during training to offer encouragement, and he is proud that Christopher Church, the young friend he calls his son, also joined the program because, "these are skills he can always use to support himself."

Christopher adds, "This is one of the ultimate chances a person can get. It's not just that it's free. It's a chance to better yourself for your family. Nothing was going to stop me from finishing this training. This is something where I can say, 'I'm qualified.'"



WHEN YOU ARE HOMELESS, the first step to a job and a stable living situation can seem insurmountable. Christopher Place Employment Academy is an intensive residential program that makes the first step to a new life possible for men willing to make a long-term commitment to positive change. Many successful graduates of the program first learned about it when they arrived at Our Daily Bread for the daily meal. Christopher Place supports formerly homeless men in the transition from a lifestyle of homelessness and substance abuse or dependency to a positive routine and a better future.

Alexandros Meritis came to Christopher Place directly from prison. “Some people take baby steps into addiction,” he says. “Not me. I am as severe an addict as you can get. My first arrest for possession, I was 16.” When he went to prison for the last time, he made a decision to get sober. As his release date neared, he started researching programs to help him get his life on track for the first time.

“I tried and failed sobriety a few times,” he says. “They say what you put into it you get out of it. So this time I gave it everything. If I want to be a better person, a better father to my son, my sobriety has to come first. The way I see it, I had my chance to have the easy life. I came from a good family. But I screwed it up, and now I have to put in the extra effort. I’m thankful for this program. It doesn’t do the work for you, but it takes away the stress of all the other variables so I can focus on myself.”

At two years sober, Alexandros has a stable job as a restaurant manager, improved relationships with his family and a plan for the future. “Everything I have now—a bank account, a good job, trust—at work I’m the boss, and people look up to me. For anyone who knew me in the past, it’s unbelievable the things I have now, and I owe it all to Christopher Place.”

# CONTINUING A 35-YEAR ADVENTURE

OUR DAILY BREAD has served a hot meal every day without interruption since 1981. Today, 40 volunteers serve up at least 130 casseroles to more than 700 people each day. At its 35th anniversary, that adds up to more than 7 million meals, and ODB remains a place where all are welcome, where people whose lives are burdened by the hardships of the human condition are served with dignity and reverence. Food opens the door, and then guests are invited to explore a wealth of programs and services that build up the human spirit.

Judith Giacomo got to be one of the longest-serving volunteers at Our Daily Bread—once a month, every month, for the program’s entire 35-year lifespan—by starting young. “I’d been married only a year, we’d just moved to Baltimore and I was open to finding some extra things to do. Word went out at our parish that this new soup kitchen had started. I volunteered, and I’ve loved the experience ever since.”

She recalls Sister Josanna Abromaitis, SSND, ODB’s first director, as “a wonderful nun—she ran it like a ship. Things have always been done in an orderly way and done very well.” In the early days, when ODB served about 150 people a day, Judith discovered the joy of dishing out portions for the volunteer servers to deliver to guests. Today, she’s known for the colorful aprons she wears. “I love working with the food, and it gives me the opportunity to observe. I look out at the weather, and whether it is blisteringly hot or sleeting, they come in, eat and leave in a timely manner.

“To me, that is the ultimate in kindness and respect for others,” she continues, “to make a place for one who is waiting, when anyone would want to prolong the visit. I’m 71, and I plan to prolong my visit here as long as I can.” She is proud that the current Our Daily Bread Employment Center has room for many programs that invite guests to linger, learn and continue on their journey well-nourished by the experience.





# AFTER A LONG JOURNEY, A PLACE TO CALL HOME

BASILICA PLACE shares an anniversary with Our Daily Bread—it opened in 1981, founded on the belief that all people, regardless of their religion, beliefs, race or financial means, are entitled to a home. In the heart of Baltimore's cultural district, this Catholic Charities' Senior Community is a diverse, welcoming community offering affordable housing with amenities and services that promote good health, happiness and a sense of self-worth for all residents.

When Robert Leigh set up housekeeping at Basilica Place, in a corner apartment with a million-dollar view, he didn't expect this would be the home he would inhabit longer than any other. "I was 63, and my dad and uncle had died in their sixties, so I thought, this is just a short stop," he laughs. "It's been 20 years, and I'm a healthy 83, so I could be here another 20!"

Born in Nebraska, he has spent most of his life on the road—as a sales representative and then a management consultant and efficiency expert. Two marriages had ended in amicable divorces, so he was free to pursue work that kept him traveling all over North America. He has lived in Alaska, Connecticut, Washington and Philadelphia. He eventually moved to Baltimore to be close to his two adult sons. When he closed his last business, "I found out one thing—when your income is reduced, your expenses have to be reduced."

His home is a reflection of a life well-lived—his mother's baby grand piano has a place of honor in the small living room, and family photographs, artwork and mementoes of his travels adorn every wall and surface. His orderly kitchen and fully networked entertainment system reflect two of his passions—efficiency and computers. He explores the city on long walks and enjoys getting to know his neighbors. "In a place like this, you have the opportunity to make friends with people you normally would not have come in contact with. It expands your horizons and makes the day more interesting. I've enjoyed it here."

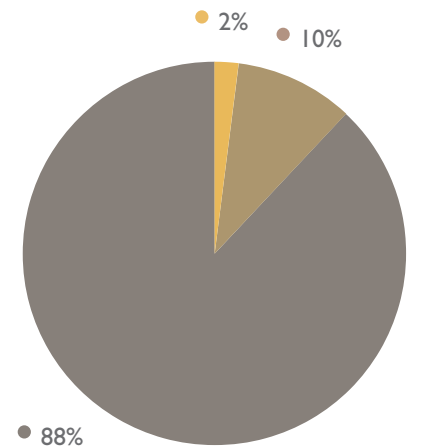

## *Assisting People on Their Road to Self-Sufficiency and Better Quality of Life*

Secured 447 permanent housing placements for individuals who needed a stable place to live; 79% of these placements were unsubsidized.

Secured job placements for 341 people who were out of work.

Served 589,051 meals to men, women and children who were hungry.

Assisted 17 people in obtaining their U.S. citizenship.

Assisted 11,039 individuals with emergency, intake and case management services and provided 135,775 bed nights for people without a place to sleep.

Taught English, computer literacy and citizenship classes to 587 immigrants to assist with their transition to the U.S., serving an average of 45 students per day; 33% significantly increased their level of proficiency.

Trained 34 individuals who earned Automotive Service Excellence (ASE) certification in Refrigerant Recovery and Recycling and provided job placement assistance to 23 individuals. The average starting wage was \$12.00-13.00/hr.

Provided affordable apartments with additional services to 1,887 low-income older adults.

Provided housekeeping, laundry, personal services and daily meals to 224 residents through the Congregate Housing Program to help the residents remain in their apartments longer.

Assisted 896 individuals in accessing 1,632 services through the Answers for the Aging program.

## *Supporting Children and Families to Overcome Barriers Toward Better Futures*

Assisted 97 children in the transition from a residential setting to a less restrictive environment and assisted 60 children in the transition from a residential setting to living with a family member.

Operated two special education schools where 55% (105 of 192) achieved a reduction in problematic behaviors, and 65% (124 of 192) students demonstrated one year or more increase in reading test scores.

Assisted 75 families with international adoptions, 244 families with pregnancy, parenting and post-adoption services, 133 families with kinship caregiver support and 69 children in treatment foster care.

Reunited 844 unaccompanied minor children with their families, provided family reunification services to 852 sponsors and served 1,390 clients in other immigration legal matters.

## *Providing Care for People to Improve Their Health and Wellness*

Provided more than 26,000 mental health assessments, crisis interventions and treatment sessions for children and families.

Provided adult medical day services for 33 people who require special daytime care.

Provided 2,887 welcoming, bilingual health care visits to 1,469 immigrants who have no other access to care; 59% of patients receiving care for chronic conditions had their condition controlled.

Conducted 196 conflict mediations (interruptions) by Safe Streets that likely would have resulted in gunshot violence.
